Frame & Body

- Frame-cracks, corrective welds, or rusted through
- Dog tracks-bent or twisted frame

Engine

- Oil leakage, excluding normal seepage
- Crack block or head
- Belts missing or inoperable
- Knocks or misses related to camshaft lifters and push rods
- Abnormal exhaust discharge

Transmission & Drive Shaft

- Improper fluid level or leakage, excluding normal seepage
- Cracked or damaged case which is visible
- Abnormal noise or vibration caused by faulty transmission or drive shaft
- Improper shifting or functioning of any gear
- Manual clutch slips or chalters

Differential

- Improper fluid level or leakage, excluding normal seepage
- Cracked or damaged case which is visible
- Abnormal noise or vibration caused by faulty transmission or drive shaft

Cooling System

- Leakage including radiator
- Improperly functioning water pump

Electrical System

- Batter leakage
- Improperly functioning alternator, generator, battery, or starter

Fuel System

- Visible leakage

Inoperable Accessories

- Gauges or warning devices
- Air conditioner
- Heater & Deforester

Brake System

- Failure warning light broken
- Pedal not firm under pressure (DOT spec.)
- Not enough pedal reserver (DOT spec.)
- Doesnot stop vehicle in a straight line (DOT spec.)
- Hoses damaged
- Drum or rotor too thin (Mfgr. Specs)
- Lining or pad thickness less than 1/32 inch
- Power unit not operating or leaking

Steering System

- Too much free play at steering wheel (DOT specs.)

Suspension System

- Ball joint seals damaged
- Structural parts bent or damaged
- Stabilizer bar disconnected
- Spring broken
- Shock absorber mounting loose
- Rubber bushings damaged or missing
- Radius rod damaged or missing
- Shock absorber leaking or functioning improperly

- Thread depth less than 2/32 inch
- Sizes mismatched

- Visible Cracks, damage or repairs
- Mounting bolts loose or missing
