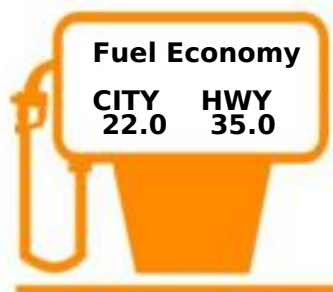

- Abnormal exhaust discharge

- Improper fluid level or leakage, excluding normal seepage
